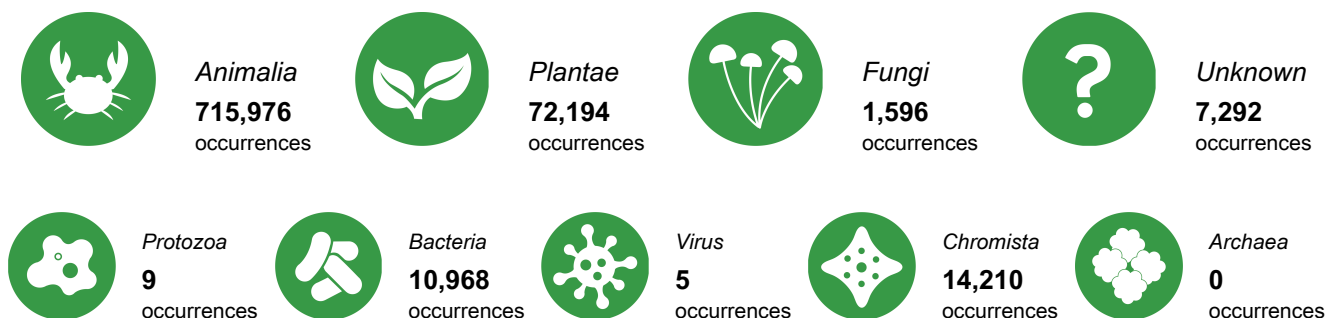
## United States Virgin Islands

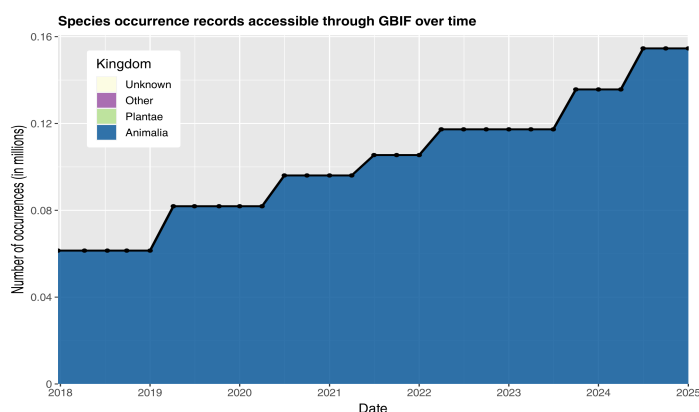

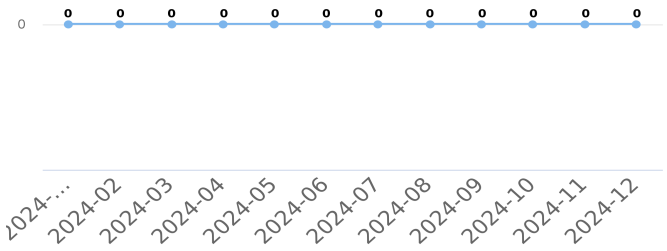
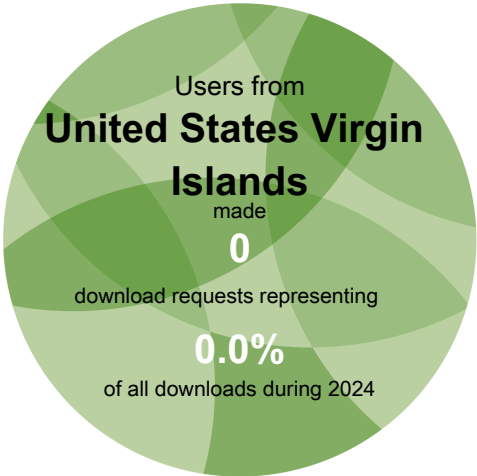


Number of records published by institutions in United States Virgin Islands, categorized by kingdom

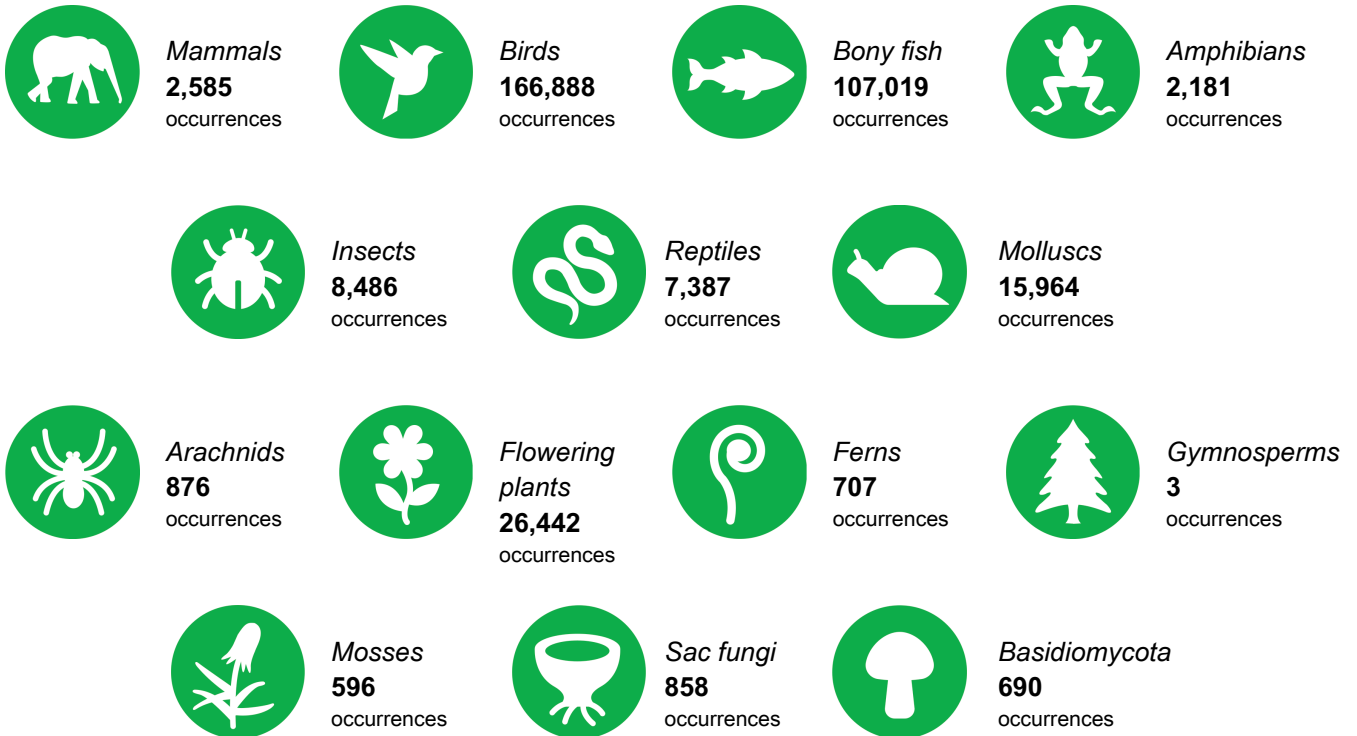


Monthly downloads requested by users in United States Virgin Islands

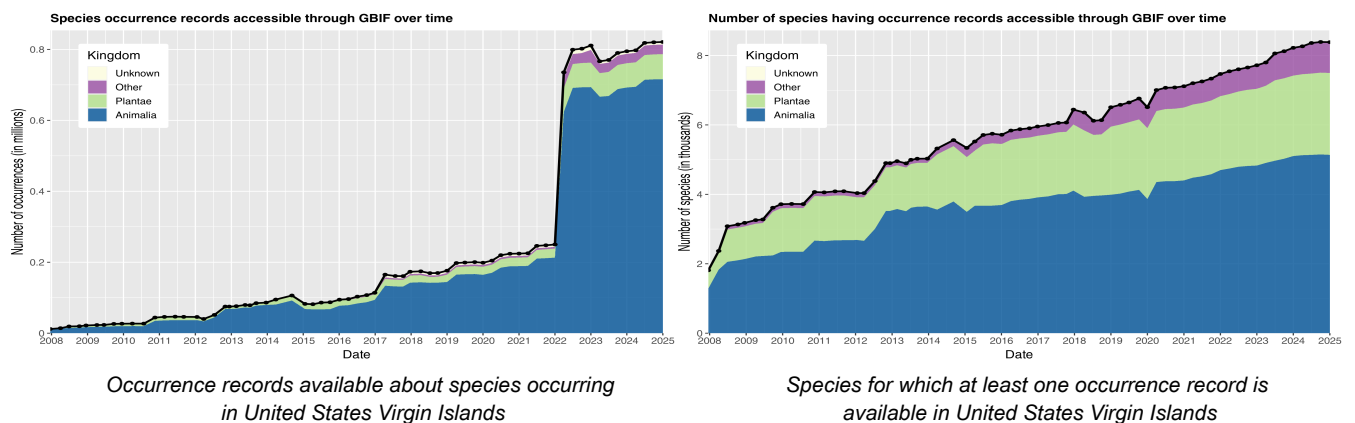

#### WHY MIGHT THE AMOUNT OF MOBILIZED DATA DECREASE?

Datasets are sometimes removed by publishers, but more often decreases in the number of records are due to the removal of duplicate records and datasets.

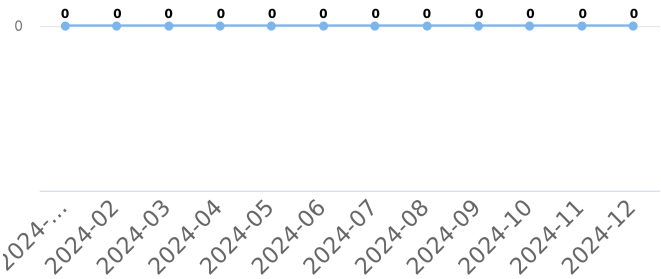

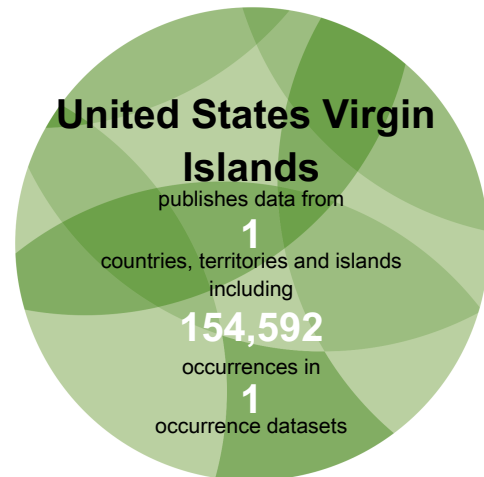
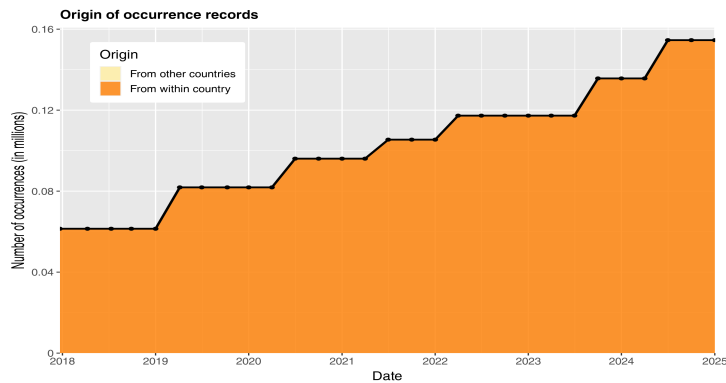
